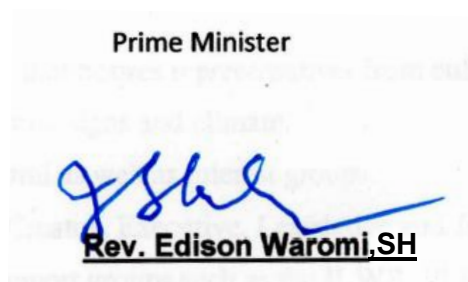

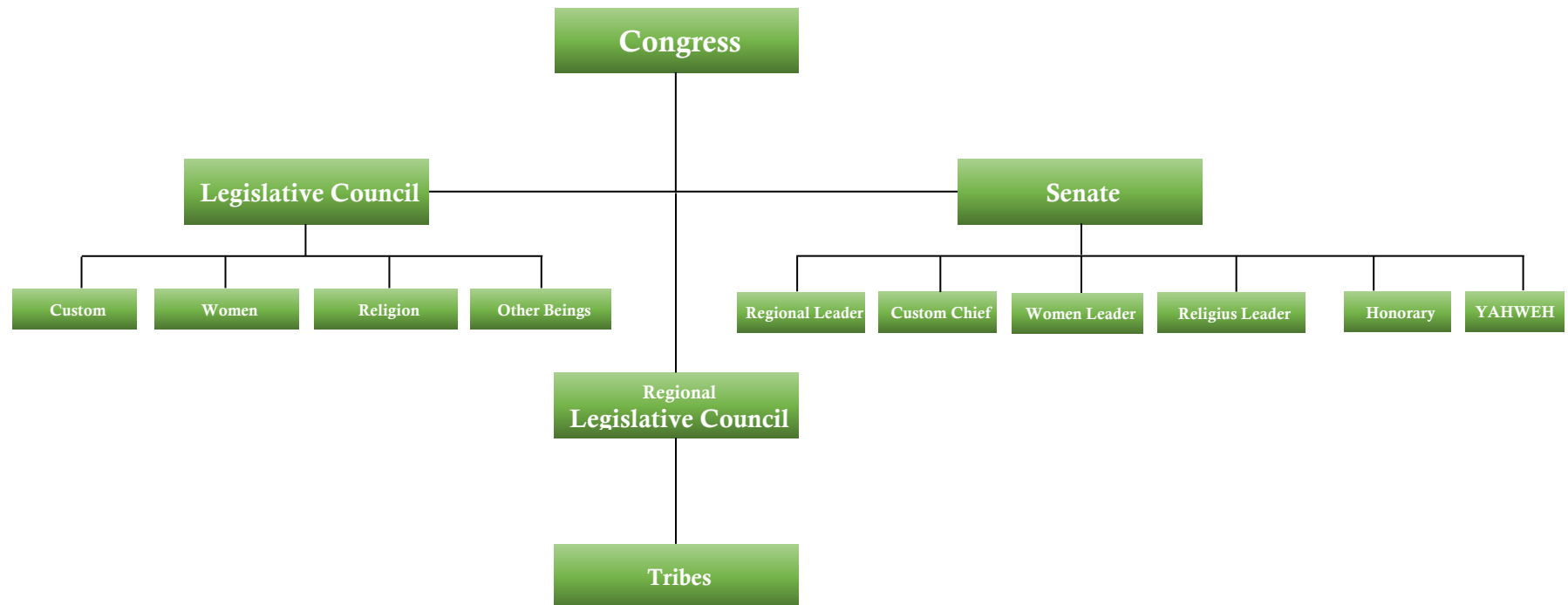

Explanation:

1. **Constitution** is the legal basis for running the government.
2. **Congress** is the highest decision making for making decisions within the government.
3. **President** is the head of the government, the highest mandate holder and head of the Executive Council who holds the power to direct the executions of all government powers to for a free and independent West Papua.
4. **West Papua Army** is the combatant arm of the Provisional government for a free and independent West Papua.
5. **Prime Minister** shares the executive power with the President to implement government policies and programmes for a free and independent West Papua.
6. **Legislative Council** is the parliament of the government that houses representatives from cultural regions representing the Creator, spirit beings, plants, animals, matter, (land-, sky-, and sea-) scapes, nature signs and climate.
7. **Senate** is the deliberative representation of regional cultural as well as interest groups.
8. **Senators** are leaders of various parties: YAHWEH, the Creator, Executive, Legislative and Judicative Chairs at the Regional Governments, as well as leaders of women's groups/ figures, leaders of support groups such as the ILWP, IPWP, Free West Papua Campaign, AWPA Sydney, and other groups from inside West Papua, within Melanesia and around the world.
9. **Board/Council org Ad-hoc Board/Council** are non-departmental bodies/ councils of the government, established to execute certain tasks, as follows:
 - a. Constitutional Board, an ad-hoc body tasked specifically to draft and formulate the Constitution of West Papua Government;
 - b. Supreme Advisory Council, an ad-hoc body tasked to give advice and critics and recommendations to Government, where the submission of the council is obligatory for the government to respond or follow up. This body consists of Churches Council, Military Council, NGOs and leading figures both from West Papua and from around the world.
 - c. Defence and Security Council,
 - d. *West Papua Trust Fund*,
 - e. *West Papua Central Intelligence Services*.

10. **West Papua Police** is the police of West Papua government.
11. **Executive Council** is the executing body of the government businesses.
12. **Judicative Council** is the supervisory and judiciary institution of the government.
13. **Regional Government** is the executing body of the government at the regional government
14. **Regional Government** represent the cultural groupings within West Papua, the collective body for all tribal elders in each cultural group in West Papua.
15. **Tribes** is responsible for executing government policies and businesses at the lowest level. According to our Green State Vision, we believe that Tribal Community and Tribal Elders are the ones who have proven as responsible agencies and agents for sustainable living in New Guinea island. We are committed to preserve and promote our traditional values, norms, and systems at the lowest level of our government in order to ensure harmony and justice among all communities of beings in New Guinea and across the globe.



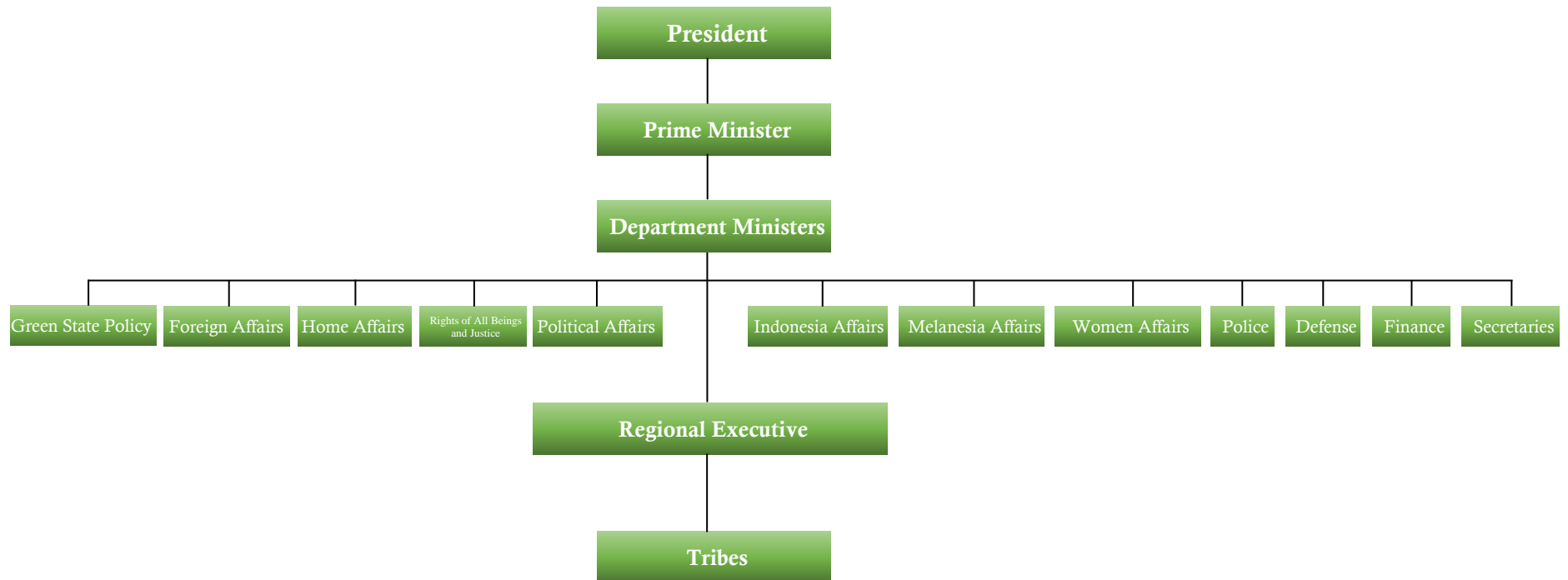

Explanatory Notes:

1. **Congress** is the government body that holds the highest authority of the government. It consists of Legislative Council and the Senate. Senators and Parliamentarians are collectively called Congressman or Congresswomen when they attend Congress Forum.
2. **Legislative Council** is the parliament of West Papua Government.
3. **Senate** is the representative body of the regions and interest groups.
4. **Custom** hosts the representatives of the tribes within the cultural areas or the regional government.
5. **Women Representative** represents women's voice and interests.
6. **Religious Representative** represents the voice and interests of the religion's organisations and/ groups, including traditional religions.
7. **Other-Than Human Representatives** represent all other beings than human beings, that is, Creator, spirits, plants, animals, matter, scapes, natural signs and climate.
8. **Regional Legislative Council** is the parliament at regional government that represents all tribes and interest groups within the region
9. **Tribes** is the lowest house of parliament at tribal and clan levels that support the government at the lowest level.
10. **Regional Leaders** are the Head of Regional Executive, Chair of Regional Legislative Council and Head of Regional Judicative Council.
11. **Customary Chief** are the Tribal Elders within each Cultural Group.
12. **Women Leaders** are the leaders of women's organisations or certain women figures within a region.
13. **Religious Leaders** are leaders of religious organisations such as Synod Leader, President, or Bishop of certain religions or church organisations.
14. **Honorary Member of Congress** are organisations or individuals, departments or officers who are appointed by the government or by Legislative Council to become Honorary Members representing themselves or their organisations.
15. **YAHWEH** is the Creator of All Beings.

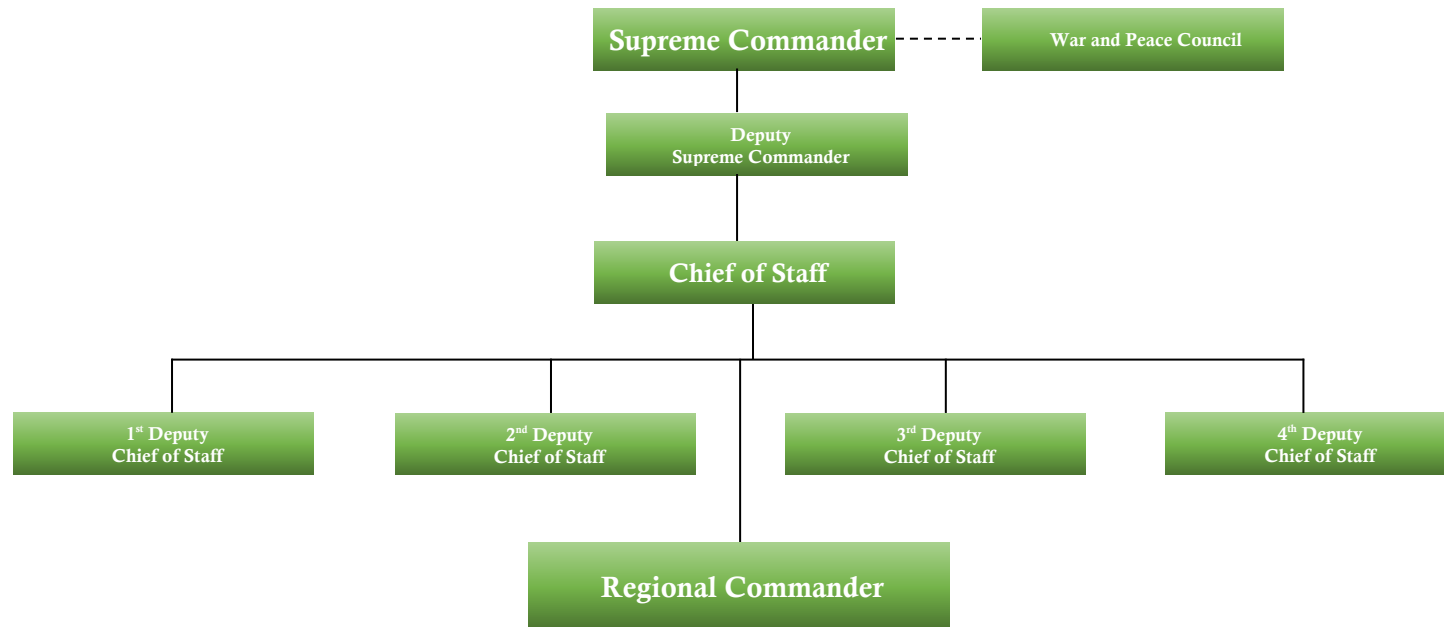
The Interim President establishes Regional Executive Offices, and the Prime Minister appoints Heads of Regional Executive Offices.

Explanation:

1. According to the Summit of all Military Commanders in 2018, the existing military commands stay as they have been since their establishments to allow an organic process of unification of the command structure. All parties: The West Papua Revolutionary Army (WPRA) of Free West Papua Campaign, West Papua National Liberation Army of the Free Papua Movement (TPN PB OPM) of West Papua National Coalition for West Papua and the Papua National Army of the Federal Government of the Republic of West Papua
2. The Military Summit approved the name West Papua Army (henceforth WPA) to be used as the name of unified command of military arm of the United Liberation Movement for West Papua (ULMWP)
3. Following up the passing of the Constitution of the ULMWP Provisional Government in October 2020, the President established the Government of ULMWP on December 1st, 2020, and announced the formation of Government Departments on May 1st, 2021, as well as appointing the abovementioned Military Commanders.
